#### **Child Pass**

## 5th grade & under - free (must be with a paid adult)

All children 5th grade and under are free of charge however this does not include program registrants for Kids Club (during Club hours), drop-in classes, dance & exercise programs, contracted classes, sport leagues and other programmed activities in the facility.

#### **Disabled Veteran**

Must present veterans Medical Card with picture, indicating service related disability

These rates are subject to change based upon demand and changing market conditions.



Paid Daily Walk-in guest and Pass holders are entitled to use of the gymnasium, weight room, jogging track, arcade area and gym restrooms.

Use of the gym, weight room & jogging track is only available during normal hours of operation & when the designated areas are not being utilized for scheduled Department programs or reserved activities & events.

An Annual Pass may be paid in full or by an auto withdrawal. With the auto withdrawal, the first quarter installment is paid at the facility when the pass is purchased, the remaining balance is automatically deducted from a debit or credit card account for the next consecutive 3 months.

A \$1.50 charge will be added to each installment for annual pass holders utilizing the auto withdrawal system.







#### **Pass Cancellation and Refunds**

Daily Walk-in fees, 30 Day Pass fees and 90 Day Pass fees are not eligible for a refund.

Annual Pass fees paid in full at time of registration are eligible for a refund under circumstances involving severe medical conditions, customer satisfaction concerns or relocation out of area.

The Department will review the date of request and the date of purchase in evaluating the refund request. The customer may or may not be eligible for a refund depending upon the time of request in relation to the number of months passed within the effective dates of the year purchased.

The Department will calculate what the customer would have paid at the 30 day pass rate for each 30 day period used and refund the difference between that amount and the amount paid for the Annual Pass.

Additionally, a \$5.00 refund processing fee will be applied.

The Department will not refund or modify beginning or ending pass effective dates due to participant's lack of use or inability to use due to personal injury or other reason.

With auto withdrawal customers, Annual Pass fee refunds will be charged \$10.00 for processing fees associated with removing the customer from the auto withdrawal system.
